Global Citizenship Institute Conference



The GCI's inaugural conference will be held October 6-7, 2010 at the Adam's Mark Hotel in downtown Buffalo. Superintendents, Jeff Rabey (Depew) and Mark Crawford (West Seneca) pictured left, are co-chairs of the Institute and are working with a diverse group of educators from the area to **promote global understanding, literacy and social responsibility among students, school staff and leadership, parents and communities. Their intent is to focus on education, culture, business/technology, and human rights.**

The group recognizes there are many varied partnerships, visitations, exchanges, and other learning activities taking place in 2010. Its purpose is to facilitate the exchange of those ideas and activities among all school constituencies and communities in the region. The GCI hopes to engage all these parties in conversation in order to expand their awareness and to take action.

There are two major themes within this conference. One is **social justice and social responsibility**, especially as they relate to basic human rights, genocide, and issues commonplace in third world countries. The other is **educational and cultural exchange and understanding**.

The Conference will feature two keynote speakers: Dean Mary Gresham, Ph.D. Graduate School of Education, University at Buffalo; and Aimable Twagilimana, Ph.D. Professor of English, Department Head, African Studies, Buffalo State College. The theme of the 32nd annual conference, "Strong Foundations: Fundamentals in Finance, Law and Governance" attracted nearly 250 people on August 4th to Salvatore's. Non-Instructional Leader Summer Seminar..... Year 2


About 65 non-instructional supervisors attended a workshop on July 21st at the Millennium Hotel in Cheektowaga. Transportation and Facilities Supervisors, Cafeteria Managers and others attended the session to learn more about the legal and practical elements of supervision. The Hodgson Russ legal team, pictured left, presented three short seminars.



The kickoff session, by Ryan Everhart and Dylan Pauly, encouraged school leaders to exercise their authority and pay serious attention to the ever-changing Special Education regulations and issues, especially as they relate to IDEA and RtI. Karl Kristoff presented “Investigating Third Party Complaints,” and offered advice on what to do before, during and after the investigations, including a four page checklist. Since we live in such a litigious society, Dave Farmelo offered dozens of ways to protect department supervisors and districts in his session on “Limiting and Preventing Liability Related to Sports.” Overall, it was a very informative day.

Organizing an Effective School Office... A Principal and Secretary Partnership

Do you work late into the evening hours and on weekends? Is your office cluttered with stacks of reading materials, memos and file folders that never seem to go away? Are you late to many of your meetings? And most of all, do you long for the days you can



spend meaningful time as an instructional leader? Jill Pellis, veteran principal at Williamsville Transit Middle School, lived that scenario for many years ... until she found a way to organize herself and the office.

Jill shared an inspiring story of organizational transition with 15 office teams on July 28th. She demonstrated how she and her secretary, Laurie Wachowiak, de-cluttered, reorganized, and virtually restructured their communication system so that Jill could spend two full days per week doing what all principals want to do: get into the hallways and classrooms to lead instruction.
